The CWBA's Annual Business Meeting and Passing the Gavel Celebration will be held during the 46th CWBA Convention at 6:30 p.m. on Saturday, May 20, 2023, at the luxurious Park Hyatt Beaver Creek Resort and Spa. All members-especially new members-are welcome and encouraged to attend. You will not want to miss this fantastic weekend filled with inspiring, empowering, and educational presentations. I promise you will feel renewed and recharged.

During the Annual Meeting dinner, the 2023-24 CWBA Board of Directors will be sworn in by Denver County Court Presiding Judge, the Honorable Nicole Rodarte. Please use the electronic ballot linked here to cast your vote for the 2023-24 Board prior to the Annual Meeting.

This year's Convention theme is "Leading together. Uniquely united," a twist on the year-long theme of "You Uniquely Belong." The programming will focus on making change, celebrating differences, and working together as one. CWBA's Convention Committee, led by Kendria Pearson and Sally Roller, has curated an intriguing lineup.

Highlights include a Friday afternoon writing workshop unlike any you've previously attended. Robert Russel, Chief Deputy of the Denver District Attorney Office's Appellate Division, Meg Satrom of Sheridan Ross, P.C., Stephanie Williams, attorney at Todd Collins & Associates, LLC and Angie Nelson, Senior Counsel at Microchip Technology, Inc., will focus on workplace writing with an emphasis on day-to-day communication. Participants may choose from among the following breakout sessions: the benefits and pitfalls of the female voice in the

workplace; writing introductions in brief and motions; writing contracts and other transactional documents; and creative aspects of writing.

Our Mary Lathrop Trailblazer Award presentation and dinner on Friday evening features this year's honoree, Patricia M. Jarzobski, a past president of the Colorado Women's Bar Association and of the Colorado Bar Association, a mentor to many, and a significant contributor to Colorado's legal community.

Saturday kicks off with a breakfast keynote from Ellen Burton, who will empower attendees to access their innate talents, such as emotional intelligence and strategic thinking, to make workplace culture more inclusive. Mid-morning will feature a panel presentation on the challenges of a diverse judiciary and will be led by Jennifer Yim, Executive Director of the Utah Judicial Performance Evaluation Commission. The panel will feature Judge Nicole Rodarte, Colorado Supreme Court Justice Monica Márquez, 12th Judicial District Judge Crista Newmyer-Olsen, and 19th Judicial District Chief Judge Julie Hoskins. Lunchtime will feature a fireside chat with Sgt. Carla Havard of the Denver Police Department and Chandra Thomas Whitfield, Co-Host and Producer of Colorado Public Radio's "Colorado Matters" program. They will explore topics such as the ways in which indigenous and marginalized communities interact with the criminal justice system. After lunch, attendees may choose from two concurrent sessions. One session will feature Liz Rita and Anne McCord of Investigations Law Group LLC. They will explore how having five generations in the workplace today impacts workplace complaints, compliance, and investigations. Another

session will feature Jon Olafson, a shareholder at Buchalter. He will discuss the ways in which the Colorado **Rules of Professional Conduct** require attorneys to investigate and understand their biases and use their knowledge on bias as an opportunity to learn and grow. Late afternoon will feature the popular judicial and transactional/corporate counsel roundtables.

Sunday morning will feature a LIVE *On* What Grounds, with President-Elect Emma Garrison and Dr. Lisa Calderón, Executive Director of Emerge Colorado, an organization dedicated to giving women the tools needed to run successfully for elected positions. The fireside chat will empower attendees to use their voices and put themselves out there.

I am extremely grateful to the 2022-23 Board and several rock star committee members for their hard work and steadfast dedication to furthering CWBA's mission. I look forward to highlighting the board's accomplishments during the Passing the Gavel celebration and in my final President's Letter. Thanks, too, to this year's Nominating Committee-assembled by President-Elect Emma Garrison and chaired by Immediate Past President Gina Glockner-for recruiting and selecting the proposed slate of Board members, officers, and committee chairs.
